STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area. **DO NOT** store for prolonged periods in direct sunlight. **DO NOT** use this container for any other purpose. Triple rinse containers before disposal. Add rinsings to spray tank. **DO NOT** dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots in compliance with relevant Local, State or Territory government regulations. **DO NOT** burn empty containers or product.

SAFETY DIRECTIONS

Poisonous if absorbed by skin contact or swallowed. Will damage eyes. Will irritate the skin. Avoid contact with eyes and skin. **DO NOT** inhale spray mist. When opening the container, preparing spray and using prepared spray, wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow-length PVC gloves and goggles.

For space applications wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow length PVC gloves, goggles, half facepiece respirator with dust cartridge or canister.

If product in eyes, wash it out immediately with water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves, goggles, respirator and if rubber wash with detergent and warm water and contaminated clothing.

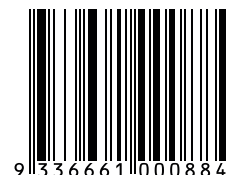
